Should we ask you to provide certain information by which you can be identified, then you can be assured that it will only be used in accordance with this privacy notice.

How is personal information collected?

We collect information:

- Through our online mailing signup form
- Through job or volunteer application forms
- In the course of our work with you, for example if you provide information to a member of staff in order for them deliver or monitor one of our projects
- Through partnership agreements
- Through networking events
- · Occasionally through our interactions on social media
- Through publicly available sources such as companies house, charity commission and official websites
- Through donations made to us through online giving platforms, such as JustGiving and Bt MyDonate



What personal information do we collect and how is it used?

Level Trust collects personal information for the following purposes. We will use this information to provide the services requested.

What does legitimate interest mean?

In order to undertake its charitable activity and account for its activities to funders, regulators and other stakeholders, Level Trust has to collect and process a certain amount of data, some of which will be personal data.

Why do we ask for sensitive data?

We sometimes ask for sensitive data, such as disability and ethnicity to help us with equal opportunities monitoring so we can demonstrate that we are reaching all sectors of the community, and fulfilling our commitment to equal opportunities. When we compile this data, it is done anonymously.

We ask for information about medical conditions in order to protect the health and wellbeing of staff, volunteers and project participants.

Data sharing

We use data to compile and share anonymised reports, which helps us to demonstrate our commitment to equal opportunities as well as to demonstrate to funders the impact of our project.

In occasional circumstances, we may need to disclose your details, to police, regulatory bodies or legal advisors.

Data retention and security

We will take reasonable precautions to ensure your data is not lost, misused or falsely altered. Data is only retained for as long as we need it to provide you with the service you asked for.

Data Processing

Level Trust has written contracts in place with the following third parties that we use to process data:

The use of automated decision making

Your data is not used in any automated decision making (making a decision solely by automated means without any human involvement) or profiling (automated processing of personal data to evaluate certain conditions about an individual).

The use of cookies on our websites

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.
